#### SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

*ARP-ESSER Application* – *Part 2*: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. Approximately, 13 meetings were held with local and school organizations including, The Kingston Boys and Girls Club, Ulster Immigrant Defense Network, Center for Creative Education, Citizens Action, Kingston Emergency Food Collaborative, Ulster Department of Youth, Kingston YMCA, Kingston Teachers Federation, Ulster BOCES, Kingston Administrators Association, Kingston Bilingual Family Workers, Kingston Homeless Coordinators and KCSD District Leadership Team (consisting of Parents, Teachers, Community Members, Students, Board Members and Administrators).

Three "Virtual Town Halls" were held and a Thought Exchange (on-line survey too) was launched that received almost 1000 "thoughts".

The District has scheduled in-person public input sessions on December 11th, March 5th, May 7th and June 1st. Presentations on progress and input will be provided to the Board of Education at public meetings in September, December, March, May and June.

In the space provided below, please describe the extent to which and how the funds will be used to implement prevention and mitigation strategies that are, to the greatest extent practicable, consistent with the most recent CDC guidance on reopening schools, in order to continuously and safely open and operate schools for in-person learning.

Funding will be used to purchase and distribute appropriate PPE to each building in the District. ARP funding is also being used to pay the salary of the required COVID 19 Director (Registered Nurse) to direct and organize all COVID 19 mitigation strategies, communicate information and complete all required reporting.

Support to nurses, clerical, substitutes for hearing and vision testing and additional support.

ARP funding is also being used to add teaching staff to allow for smaller class sizes and the maintenance of cohorts at the elementary level. Personnel who monitor and supervise required COVID 19 isolation rooms will also be compensated using ARP funding.

4. In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.

The district will use base line STAR testing, district created benchmark assessments and Next Steps in Guided Reading to establish data for learning loss. The same assessments will be used quarterly to determine growth and progress toward eliminating learning loss. New York State 3-8 testing, Regents exams and student report cards will also be utilized to determine academic progress.

Progress of Social Emotional Learning will be measured using staff, student and parent surveys, analysis of discipline data and attendance data.

Students who are not showing appropriate progress will be provided supports - RTI, AIS and after school tutoring "Learning After the Bell". RTI/AIS progress monitoring and data meetings will be utitized to analyze student performance data.

The district has implemented an expanded summer program (took place during the summer of 21 and will continue for next three years). This program featured expanded hours, SEL curriculum and partnerships with multiple community based organizations. These organizations offered SEL, Restorative Practices, Drivers Education, health and wellness classes, mindfulness and inclusion and equity courses.

Full wrap around programming has been implemented in all district elementary schools to provide extended learning time, exercise and SEL. The district has partnered with two community based organizations (YMCA of Kingston and Healthy Kids) to provide this programming.

Addition Reading and Math Specialist have been hired at the Middle and Elementary levels and AIS instrutors have been added at the High School

The District has adopted several new curricula to improve academic outcomes for all students, including Pioneer Valley Reading, Into Math and a new K-4 knowledge based Social Studies curriculum. Funding will be used to provide professional development and purchase needed materials to properly implement these curricula with fidelity. In-house curriculum writing and development will also be funded through ARP.

A one to one Chromebook inititiative is being launched with the goal of completion for June 2023. The distirct will purchase the neccesary hardware and has hired two new Instructional Techology Coaches to provide teachers with PD and support. ARP funding will also be used to hire addition IT support for programming, repairs and maintenance.

Additionl training for our Montessori teachers and administrators will be funded through ARP funding. KCSD has one Montessori school, George Washington Elementary. This program is in it's 11 year and the training will allow us to continue and expand this initiative.

The district will expand our physical health and wellness program to include more access to play areas in all buildings and add programming for free swimming lessons for all studetns (Kingston is a river city and has experienced several drownings over the last ten years).

The district has adopted several new curricula focused on academic improvement of students with disabilities and ENL students, including Fast For Word, Wilson Fundations and Orton Gillingham.

Bilinigual family workers, Social Workers and Guidance Counselors have been hired to work with ENL students and their families.

The district has also ebarked on an initiative to train multiple staff as Registered Behavior Tehnicians to assist faculty and administration with behavior issues stemming from COVID 19 and stressors outside and inside school.

Additional Social Workers have been hired to ensure each building has a dedicated Social Worker.

The district has partnered with Astor to provide mental health service to all students and Deveroux to provide training and workshops for our faculty/staff to assist students with special needs.

A Department of Diverstiy, Equity and Inclusion has been created with two positions dedicated to DEI. The Executive Director of Diversity, Equity and Inclusion will focus on curriculum, training and staff learning and the Director of Recruitment, Retention and Equity will focus on recruting and retaining our educators of color.

Through a partnership with a community arts program, The Bardavon, the District will expand access to the Arts for all students.

The District will partner with Bard College and expand the Borthers at Bard mentoring program at Kingston High School. This program provides mentoring for young men of color in our high school.

A SIFE and Newcomer program has been implemented at the secondary level.
