Dear Kingston Parents and Guardians:

Every child is extremely important to all of us in the Kingston School District. We are concerned with the total development of all children. We know that children perform better in classrooms and in all other aspects of their lives when they have proper nutrition, necessary for the healthy growth of their minds and bodies. Therefore, we provide breakfast and lunch in our schools every day.

You will be pleased with the quality of our breakfast and lunch programs. We invite all students to show their support for their school food service program by having a healthy breakfast and lunch at school every day. Pricing for the 2019-2020 school year for breakfast will be one dollar (\$1.00) for paying students and no cost for students approved for free or reduced price meals. Lunch prices will be two dollars and sixty cents (\$2.60) for elementary and middle school paying students, two dollars and eighty five cents (\$2.85) for high school paying students and no cost for students approved for free or reduced price meals. All varieties of milk will cost \$.60.

Many households are eligible for free and reduced meals due to Federal financial supplements. We want as many families as possible to qualify for free and reduced meals to bring more Federal dollars into our community and to enable us to serve more children at little or no cost. Therefore, if you believe you might qualify as per the attached guidelines, please apply. If you are in need of another application, please visit www.kingstoncityschools.org for a printable application that you can fill out, sign and send to the Food Service Department or send to school with your child to give to Food Service Personnel.

ALL children in the qualifying household receive the benefit of the free or no charge reduced price meals. This benefit can mean a huge savings for Kingston families. Don't miss out on this financial opportunity!


Foster children are eligible for free meals, as are families who receive SNAP or TANF so they should fill out the attached application. You will also be pleased to know that all information will be kept confidential, unless the attached consent form is filled out, signed and returned. Other parents, students or unauthorized school personnel will not be aware that your family is participating in this free or reduced meal program.

If you think you might be eligible, we urge you to apply. We will do everything we can to assist you.

Please contact your school's food service staff or the district's food service office, at (845)943-3663 at any time. By working together, your child will enjoy the meals that contribute to a healthy mind and a healthy body.

Important Information for 2019-2020 School Year

- **Nutrition Standards in the National School Lunch and Breakfast Programs:** The USDA has standards concerning complete (reimbursable) breakfasts and lunches. The standards implemented by the USDA make the same kind of practical changes that many parents are already encouraging at home, including:
 - Ensuring students are offered both fruits and vegetables every day of the week.
 - Substantially increasing offerings of whole grain-rich foods.
 - Offering only fat-free or low fat-flavored milk varieties.
 - Limiting calories based on the age of children being served to ensure proper portion size.
 - Increasing the focus on reducing the amounts of saturated fat, trans fats and sodium.

By following these standards, students are offered a one cup portion of a fruit and a one cup portion of a vegetable. Students are required to take at least a one half cup portion of a fruit or vegetable. The protein and grain portions, in addition to calories in student lunches, are limited. A student lunch offers 5 components: protein, fruit, vegetable, grain and milk. Milk choices will be limited to 1% white and fat free white and fat free flavored milk, available daily. Students are encouraged to take all 5 components for a well balanced meal. Students must take at least three components which must consist of a one half cup portion of a fruit or vegetable to be considered a complete, reimbursable meal. - **No Charge Reduced Meals:** Families will be happy to know that students approved for Reduced price meals will be able to receive both breakfast and lunch at no cost.
- **Consent Form:** Included in this packet is a “2019-2020 Consent to Release Free or Reduced Eligibility Information” form. Parents are encouraged to fill out the consent and return it with the Free or Reduced Meal Application if meal eligibility will be needed by any of the programs listed, during the 2019-2020 school year.
- **Paying for Meals:** As a convenience to parents, students may prepay for meals. Prepayment may be made by sending a check to school with the students. Please make the check payable to Kingston City School District Food Service and write the student’s name on the check. Students may continue to pay with cash each day they choose to make a purchase. Prepayment may also be made on-line with a credit card at www.myschoolbucks.com. The fee for each transaction is \$2.49. In addition, when visiting the www.myschoolbucks.com website parents can:
 - Establish automatic recurring payments
 - Automatically add money to a student’s account when the balance runs low
 - Receive low balance e-mail notifications at no cost
 - Review the last 90 days of student activity which will show prepayments that have been made by check, cash or on-line, in addition to all purchases made (breakfast, lunch or snacks) and follow the balance in their children’s account. There is no fee to view your children’s activity.
- **Spending Limit:** There are no restriction limits or spending limits, other than those you may impose as a parent or guardian. If you have placed a limit on your student’s account through the Food Service Office; it will remain in place until you contact the Food Service Office to have it removed. If you would like to place a spending limit on your student’s account, please contact the Food Service Office at (845) 943-3663 for further information.
- **Account Balance:** Any balance on accounts at the end of the school year will automatically be carried forward to the next school year.

FREE AND REDUCED PRICE MEAL APPLICATION FACT SHEET

When filling out the application form, please pay careful attention to these helpful hints.

SNAP/TANF/FDPIR case number: This must be the complete valid case number supplied to you by the agency including all numbers and letters, for example, E123456, or whatever combination is used in your county. Refer to a letter you received from your local Department of Social Services for your case number or contact them for your number.

Foster Child: A child who is living with a family but who is under the legal care of the welfare agency or court may be listed on your family application. List the child's "personal use" income. This includes only those funds provided by the agency which are identified for the personal use of the child, such as personal spending allowances, money received by his/her family, or from a job. Funds provided for housing, food and care, medical, and therapeutic needs are not considered income to the foster child. Write "0" if the child has no personal use income.

Household: A group of related or non-related people who are living in one house and share income and expenses.

Adult Family Members: All related and non-related people who are 21 years of age and older living in your house.

Financially Independent: A person is financially independent and a separate economic unit/household when his or her earnings and expenses are not shared by the family/household. Separate economic units in the same residence are characterized by prorating expenses and by economic independence from one another.

Current Gross Income: Money earned or received at the present time by each member of your household before deductions. Examples of deductions are federal tax, State tax, and Social Security deductions. If you have more than one job, you must list the income from all jobs. If you receive income from more than one source (wage, alimony, child support, etc.), you must list the income from all sources. Only farmers, self-employed workers, migrant workers, and other seasonal employees may use their income for the past 12 months reported from their 1040 Tax Forms.

Examples of gross income are:

- Wages, salaries, tips, commissions, or income from self-employment
- Net farm income – gross sales minus expenses only – not losses
- Pensions, annuities, or other retirement income including Social Security retirement benefits
- Unemployment compensation
- Welfare payments (does not include value of SNAP)
- Public Assistance payments
- Adoption assistance
- Supplemental Security Income (SSI) or Social Security Survivor's Benefits
- Alimony or child support payments
- Disability benefits, including workman's compensation
- Veteran's subsistence benefits
- Interest or dividend income
- Cash withdrawn from savings, investments, trusts, and other resources which would be available to pay for a child's meals
- Other cash income

Income Exclusions: The value of any child care provided or arranged, or any amount received as payment for such child care or reimbursement for costs incurred for such care under the Child Care Development (Block Grant) Fund should not be considered as income for this program.

Letter to Parents for School Meal Programs

Dear Parent/Guardian:

Children need healthy meals to learn. The Kingston City School District offers healthy meals every school day. Breakfast at school not participating in the Community Eligibility Provision (CEP) costs \$1.00; lunch at Elementary schools not participating in the Community Eligibility Provision (CEP) costs \$2.60, and lunch at the high school costs \$2.85. Your children may qualify for free meals or for reduced price meals.

Beginning July 1, 2019, students in New York State that are approved for reduced price meals will receive breakfast and lunch meals at no charge.

1. DO I NEED TO FILL OUT AN APPLICATION FOR EACH CHILD? No. Complete the application to apply for free or reduced price meals. *Use one Free and Reduced Price School Meals Application for all students in your household.* We cannot approve an application that is not complete, so be sure to fill out all required information. Return the completed application to: **Food Service Office, 118 Merilina Avenue, Kingston NY 12401, (845) 943-3663.**
2. WHO CAN GET FREE MEALS? All children in households receiving benefits from **SNAP, the Food Distribution Program on Indian Reservations** or **TANF**, can get free meals regardless of your income. Categorical eligibility for free meal benefits is extended to all children in a household when the application lists an Assistance Program's case number for any household member. Also, your children can get free meals if your household's gross income is within the free limits on the Federal Income Eligibility Guidelines. Households with children who are categorically eligible through an Other Source Categorically Eligible designation, as defined by law, may be eligible for free benefits and should contact the SFA for assistance in receiving benefits.
3. CAN FOSTER CHILDREN GET FREE MEALS? Yes, foster children that are under the legal responsibility of a foster care agency or court, are eligible for free meals. Any foster child in the household is eligible for free meals regardless of income. Foster children may also be included as a member of the foster family if the foster family chooses to also apply for benefits for other children. Including children in foster care as household members may help other children in the household qualify for benefits. If non-foster children in a foster family are not eligible for free or reduced price meal benefits, an eligible foster child will still receive free benefits.
4. CAN HOMELESS, RUNAWAY, AND MIGRANT CHILDREN GET FREE MEALS? Yes, children who meet the definition of homeless, runaway, or migrant qualify for free meals. If you haven't been told your children will get free meals, please call or e-mail **Cristina Madrid, Homeless and Foster Care Liaison at 845-706-0016** to see if they qualify.
5. WHO CAN GET REDUCED PRICE MEALS? Your children may be approved as reduced price eligible if your household income is within the reduced-price limits on the Federal Eligibility Income Chart, shown on this letter. Beginning July 1, 2019, students in New York State that are approved for reduced price meals will receive breakfast and lunch meals at no charge.
6. SHOULD I FILL OUT AN APPLICATION IF I RECEIVED A LETTER THIS SCHOOL YEAR SAYING MY CHILDREN ARE APPROVED FOR FREE MEALS? Please read the letter you got carefully and follow the instructions. Call the school at **(845) 943-3663** if you have questions.
7. MY CHILD'S APPLICATION WAS APPROVED LAST YEAR. DO I NEED TO FILL OUT ANOTHER ONE? Yes. Your child's application is only good for that school year and for up to the first 30 operating days of this school year. You must send in a new application unless the school told you that your child is eligible for the new school year.
8. I GET WIC. CAN MY CHILD(REN) GET FREE MEALS? Children in households participating in WIC may be eligible for free or reduced price meals. Please fill out a FREE/REDUCED PRICE MEAL application.
9. WILL THE INFORMATION I GIVE BE CHECKED? Yes and we may also ask you to send written proof.
10. IF I DON'T QUALIFY NOW, MAY I APPLY LATER? Yes, you may apply at any time during the school year. For example, children with a parent or guardian who becomes unemployed may become eligible for free and reduced price meals if the household income drops below the income limit.
11. WHAT IF I DISAGREE WITH THE SCHOOL'S DECISION ABOUT MY APPLICATION? You should talk to school officials. You also may ask for a hearing by calling or writing to: **Ed Carelli, Food Service Director, 118 Merilina Avenue, Kingston, NY 12401 or call (845) 943-3663.**
12. MAY I APPLY IF SOMEONE IN MY HOUSEHOLD IS NOT A U.S. CITIZEN? Yes. You or your child(ren) do not have to be U.S. citizens to qualify for free or reduced price meals.
13. WHO SHOULD I INCLUDE AS MEMBERS OF MY HOUSEHOLD? You must include all people living in your household, related or not (such as grandparents, other relatives, or friends) who share income and expenses. You must include yourself and all children living with you. If you live with other people who are economically independent (for example, people who you do not support, who do not share income with you or your children, and who pay a pro-rated share of expenses), do not include them.
14. WHAT IF MY INCOME IS NOT ALWAYS THE SAME? List the amount that you normally receive. For example, if you normally make \$1000 each month, but you missed some work last month and only made \$900, put down that you made \$1000 per month. If you normally get overtime, include it, but do not include it if you only work overtime sometimes. If you have lost a job or had your hours or wages reduced, use your current income.
15. WE ARE IN THE MILITARY. DO WE INCLUDE OUR HOUSING ALLOWANCE AS INCOME? If you get an off-base housing allowance, it must be included as income. However, if your housing is part of the Military Housing Privatization Initiative, do not include your housing allowance as income.

16. MY SPOUSE IS DEPLOYED TO A COMBAT ZONE. IS HER COMBAT PAY COUNTED AS INCOME? No, if the combat pay is received in addition to her basic pay because of her deployment and it wasn't received before she was deployed, combat pay is not counted as income. Contact your school for more information.
17. MY FAMILY NEEDS MORE HELP. ARE THERE OTHER PROGRAMS WE MIGHT APPLY FOR? To find out how to apply for **SNAP** or other assistance benefits, contact your local assistance office or call **1-800-342-3009**.

How to Apply: To get free or reduced price meals for your children carefully complete one application following the instructions for your household and return it to the designated office listed on the application. If you now receive SNAP, Temporary Assistance to Needy Families (TANF) for any children or participate in the Food Distribution Program on Indian Reservations (FDPIR), the application must include the children's names, the household SNAP, TANF or FDPIR case number and the signature of an adult household member. All children should be listed on the same application. If you do not list a SNAP, TANF or FDPIR case number for any household member, the application must include the names of everyone in the household, the amount of income each household member, and how often it is received and where it comes from. It must include the signature of an adult household member and the last four digits of that adult's social security number, or check the box if the adult does not have a social security number. **An application for free and reduced price benefits cannot be approved unless complete eligibility information is submitted, as indicated on the application and in the instructions.** Contact your local Department of Social Services for your SNAP or TANF case number or complete the income portion of the application. No application is necessary if the household was notified by the SFA their children have been directly certified. If the household is not sure if their children have been directly certified, the household should contact the school.

Reporting Changes: The benefits that you are approved for at the time of application are effective for the entire school year and up to 30 operating days into the new school year (or until a new eligibility determination is made, whichever comes first). You no longer need to report changes for an increase in income or decrease in household size, or if you no longer receive SNAP.

Income Exclusions: The value of any child care provided or arranged, or any amount received as payment for such child care or reimbursement for costs incurred for such care under the Child Care Development (Block Grant) Fund should not be considered as income for this program.

Reduced Price Eligible Students: Beginning July 1, 2019, students in New York State that are approved for reduced price meals will receive breakfast and lunch meals at no charge.

In the operation of child feeding programs, no child will be discriminated against because of race, sex, color, national origin, age or disability

Meal Service to Children With Disabilities: Federal regulations require schools and institutions to serve meals at no extra charge to children with a disability which may restrict their diet. A student with a disability is defined in 7CFR Part 15b.3 of Federal regulations, as one who has a physical or mental impairment which substantially limits one or more major life activities of such individual, a record of such an impairment or being regarded as having such an impairment. Major life activities include but are not limited to: functions such as caring for one's self, performing manual tasks, seeing, hearing, eating, sleeping, walking, standing, lifting, bending, speaking, breathing, learning, reading, concentrating, thinking, communicating, and working. You must request meal modifications from the school and provide the school with medical statement from a State licensed healthcare professional. If you believe your child needs substitutions because of a disability, please get in touch with us for further information, as there is specific information that the medical statement must contain.

Confidentiality: The United States Department of Agriculture has approved the release of students names and eligibility status, without parent/guardian consent, to persons directly connected with the administration or enforcement of federal education programs such as Title I and the National Assessment of Educational Progress (NAEP), which are United States Department of Education programs used to determine areas such as the allocation of funds to schools, to evaluate socioeconomic status of the school's attendance area, and to assess educational progress. Information may also be released to State health or State education programs administered by the State agency or local education agency, provided the State or local education agency administers the program, and federal State or local nutrition programs similar to the National School Lunch Program. Additionally, all information contained in the free and reduced price application may be released to persons directly connected with the administration or enforcement of programs authorized under the National School Lunch Act (NSLA) or Child Nutrition Act (CNA); including the National School Lunch and School Breakfast Programs, the Special Milk Program, the Child and Adult Care Food Program, Summer Food Service

Program and the Special Supplemental Nutrition Program for Women Infants and Children (WIC); the Comptroller General of the United States for audit purposes, and federal, State or local law enforcement officials investigating alleged violation of the programs under the NSLA or CNA.

Reapplication: You may apply for benefits any time during the school year. Also, if you are not eligible now, but during the school year become unemployed, have a decrease in household income, or an increase in family size you may request and complete an application at that time.

The disclosure of eligibility information not specifically authorized by the NSLA requires a written consent statement from the parent/guardian. We will let you know when your application is approved or denied.

Nondiscrimination Statement: This explains what to do if you believe you have been treated unfairly.

In accordance with Federal civil rights law and U.S. Department of Agriculture (USDA) civil rights regulations and policies, the USDA, its Agencies, offices, and employees, and institutions participating in or administering USDA programs are prohibited from discriminating based on race, color, national origin, sex, disability, age, or reprisal or retaliation for prior civil rights activity in any program or activity conducted or funded by USDA.

Persons with disabilities who require alternative means of communication for program information (e.g. Braille, large print, audiotape, American Sign Language, etc.), should contact the Agency (State or local) where they applied for benefits. Individuals who are deaf, hard of hearing or have speech disabilities may contact USDA through the Federal Relay Service at (800) 877-8339. Additionally, program information may be made available in languages other than English.

To apply for free and reduced price meals, complete only one application for your household using the instructions below. Sign the application and return the application to: **Food Service Office, 118 Merilina Avenue, Kingston, NY 12401.**

If you have a foster child in your household, you may include them on your application. A separate application is not needed. Call the school if you need help: **(845) 943-3663**. Ensure that all information is provided. Failure to do so may result in denial of benefits for your child or unnecessary delay in approving your application.

PART 1 ALL HOUSEHOLDS MUST COMPLETE STUDENT INFORMATION. DO NOT FILL OUT MORE THAN ONE APPLICATION FOR YOUR HOUSEHOLD.

- (1) Print the names of the children, including foster children, for whom you are applying on one application.
- (2) List their grade and school.
- (3) Check the box to indicate a foster child living in your household, or if you believe any child meets the description for homeless, migrant, runaway (a school staff will confirm this eligibility).
